Camping Permit and Guidelines

• ADULT SUPERVISION IS REQUIRED AT ALL TIMES.

- Tents may only be set up in designated camping areas.
 - ALL campers must report to and remain at the campsite at closing, unless it is an emergency.
 - o NO hiking after hours. (General park rules apply during park's operating hours)
 - NO rock climbing after hours. (General park rules apply during park's operating hours)
- RFP is a carry-in/carry-out facility. There are no restrooms at the campsites. Burying trash is prohibited.

• FIRES ARE ALLOWED IN DESIGNATED FIRE RING ONLY AND MUST BE TENDED TO AT ALL TIMES

- Loose ground fires are not allowed.
- Collecting firewood is limited to <u>DEAD</u>, <u>DOWNED</u> wood.
- NO TREES MAY BE CUT OR OTHERWISE DAMAGED TO GET FIREWOOD.
- o A minimum of three water jugs will be available at the campsite. These are to be used for fire extinguishing only!
- **NO** alcoholic beverages, illegal drugs, or tobacco products are allowed.
- **NO** Firearms or other weapons are allowed except that those with a proper permit may possess a concealed handgun under the requirements of NC GS 14-415.11 and 14-415.23. <u>Permit must be shown</u>.
- Do not feed the wildlife; do not leave any food out and/or accessible for the wildlife.
- The removal, destruction, or injury of any tree, flower, artifact, fern, shrub, rock or other plant, mineral, animal, or insect in the park is prohibited.
- Campers are allowed to stay no longer than 7 consecutive nights within a 30 day period.

Some of our camp sites border private land. Please respect the rights of private property owners and avoid trespassing on private land

<u>Rocky Face Mountain Recreational Area reserves the right to cancel any reservation at their discretion, with notice to client.</u> <u>Rocky Face Mountain Recreational Area and/or the NC Forest Service reserve the right to ban campfires due to dry or windy</u> <u>weather.</u>

Check-out Time: 1:00 pm at Park Office

Check-in Time: Between 2:00 pm and two hours before closing

Quiet Hours: 10:00pm until 7:00am

All parties are to be checked in during check-in times. NO ENTRY AFTER HOURS.

You must check-in and check-out with a Park Ranger.

The gate to the property/facility will remain closed (but not locked) after park hours

If anyone in the group leaves for any reason, the gate must be closed!
